Our most important order of business in December is the election of officers for 2013, according to the provisions of our by-laws:

ARTICLE VI. OFFICERS

- At the December meeting of each year, the Round Table shall elect from among its membership a President, a Vice-President, a Secretary, a Treasurer and a Member-at-Large for the Board of Directors. Officers shall serve one-year terms of office commencing January 1st and may be re- elected. All officers with the exception of the Member-at-Large may serve a maximum of two consecutive full terms of the same office, without a limit of non-consecutive terms. The Member-at-Large may serve a maximum of one consecutive full term, without a limit of non-consecutive terms.
- Officers shall be elected by a majority vote of the membership in attendance at the meeting in December.

All dues-paid members are eligible to vote and hold office, which makes this a good time to remind you to pay your dues for 2013: \$20/person or \$30/couple.

Civil War Round Table of the Ozarks Minutes of the meeting of 14 November 2012

President Bill Piston called the meeting to order at 6:30 pm. President Piston welcomed those visiting and asked them to stand and introduce themselves. No visitors were present. There were thirty four members in attendance. The minutes for the October 2012 meeting were published in the November issue of the Buck & Ball. The minutes were approved as published.

Treasurer, Richard Quinn, reported the beginning balance of \$1026.40. The income from last meeting was \$257.85. There were no expenses from last meeting. The monthly ending cash balance was \$1284.25. Money market amount reported as \$5278.33. Total Fiscal Assets as of November 6, 2012 was \$6562.58. The treasurer's report was approved by the membership.

Jim Scaminaci reported on the fund raising activities. At the December meeting, there will be at least twelve door prizes that will be given out. He reported that both Great Southern Bank and Commercial Bank have agreed to a \$500 contribution to support the organization.

Ted Hillmer, the Superintendent of Wilson's Creek, provided the following report:

- Flyers are available for the 9th Annual Memorial Illumination Display at the park, Saturday, December 8, 2012. He encouraged everyone to pick some up and distribute around the community. He mentioned the park can always use more volunteers to set up the luminaries.
- The 2013 calendar will be done by the 27th of November.
- Discussed the recent issue with the burglar at the park. The park has the remains of the soldier. They will be reinterred in the Springfield National Cemetery on April 20th, 2013. A special event is being planned that will include re-enactors for the ceremony.
- On May 20, 2013, there will be a land dedication fund raiser to raise \$150k for the Judge Keith property (sixty acres) and the additional ten acres behind the Ray House.
- January 8-13 is a Battle of Springfield 150th Anniversary event commemorating the historic events that took place in 1863.

Don Acres made the suggestion to have some sort of an event to gather donated artifacts from the community that has a connection with Wilsons Creek National Battlefield.

President Piston discussed the December meeting. The information about the meeting will appear in the December issue of the Buck and Ball. The Round Table will bring the meat and drinks. Members are asked to bring a dish. There will be items and books for sale. There will also be a round table discussion lead by President Piston.

Member John Rutherford provided further details on the 1863 Battle of Springfield: Marmaduke's Raid and the events that will take place commemorating the historic battle during January 8-13. He provided everyone with a current copy of "*Bookends*" from the Library Center describing the upcoming events.

- "A Scene of Horrors": A Medical and Surgical History of the Battle of Wilson's Creek, by Kip Lindberg and Thomas P. Sweeney, M.D. Neither Kip nor Tom could attend so Ted Hilmer discussed their book.
- "Quinine and Courage; the Battle of Springfield, January 8, 1863," by William Piston and John Rutherford, in *Springfield's Urban Histories*, ed. by Stephen McIntyre

The book opportunity drawing was held. Walt Hamer won the book.

Meeting adjourned at 7:55 pm.
