

Civil War Round Table of the Ozarks Minutes of the meeting 12 December 2012

Items were available for sale before the meeting.

President Bill Piston called the meeting to order at 6:30 pm. There were 50 people in attendance. President Piston asked Walter Hamer to give the prayer before our Christmas dinner.

After dinner President Piston started the business meeting at 7:03 pm. President Piston thanked all the members saying it was a pleasure to be the President of the Civil War Round Table of the Ozarks for this year. He gave a special thanks to the staff Dan Cunningham, Ted Hillmer, Richard Quinn, Herb Primrose, Steve Buffat, and Nancy Piston. He also thanked Michael Price for the website and Dori and Jim Scaminaci for fund raising.

Ted Hillmer, the Superintendent of Wilson's Creek, was not present to give a report.

Treasurer, Richard Quinn, reported the beginning balance of \$1284.25. The income from last meeting was \$173.75. The expenses from last meeting were \$28.20. The monthly ending cash balance was \$1429.80. Money market amount reported as \$5000.88. Total Fiscal Assets as of December 12, 2012 was \$6709.01. Mr. Quinn reported that the Christmas dinner has not yet been recorded and we have a \$500 donation from Commerce Bank. The treasurer's report was approved by the membership.

Michael Price passed out the Program Guide for the events commemorating the 150 year Battle of Springfield and lapel pins "Battle of Springfield 150 years 1863-2013". Mr. Price reviewed the events (January 8 – January 13, 2013). Mr. Price announced that there will be a new interactive website in January. Mr. Price also announced that there will be new signs/markers at the key sites related to the Battle of Springfield. Mr. Price answered questions from the membership concerning the events and new markers.

President Piston discussed the Civil War Round Table partnering with the Library to bring Fritz Klein as Lincoln to Springfield as part of the Battle of Springfield events.

Jim Scaminaci announced guest, Alice Richardson. Ms. Richardson has been impressed with the Civil War Round Table of the Ozarks and has donated many items for fund raising. Dan Cunningham presented Ms. Richardson with the Civil War Round Table of the Ozarks 50 year (1960-2010) medallion.

Jim Scaminaci conducted the drawings for gift certificates from local restaurants.

President Piston again announced items for sale.

All were voted in by the membership.

President Piston announced that there were no nominations for Vice President and Treasurer. President Piston asked if any nominations from the membership. Member Jim Robinson was nominated for Vice President and respectively declined. Member Kay Martin was nominated for Treasurer and respectively declined. This leaves both positions open.

President Piston announced that he will continue to do the opportunity drawing for books and Nancy Piston will continue to do refreshments.

President Piston asked if any old business to discuss. President Piston requested that members pay dues for 2013 and everyone paying dues will receive a Wilson Creek Calendar. President Piston indicated that dues are \$20 for individual and \$25 for couples. A member brought up that the dues had been changed in 2010 to \$25 for individuals and \$35 for couples. Treasurer Quinn indicated that he was collecting \$20 and \$25. President Piston entertained a motion to start collecting \$25 for individuals and \$35 for couples and it was approved. 150th Anniversary Commemoration of the Battle of Springfield
Tuesday, January 8, 2013, 12 noon

At noon on January 8 the Wilson's Creek National Battlefield Foundation will commemorate the 150th anniversary of the Battle of Springfield with a ceremony at Park Central Square in Springfield. The event will include speakers, living historians in period clothing, Civil War-era music, an authentic cannon, and the unveiling of newly redesigned markers for the Battle of Springfield tour. Following the noon program, a reception will be hosted by the History Museum for Springfield – Greene County, in its temporary location at 155 Park Central Square. In case of inclement weather, the noon event will also be held in the History Museum.

The 12 Battle of Springfield markers, located throughout downtown Springfield, highlight key locations and details of the battle. Although the new markers have not yet been installed, a replica of Marker 1 will be in place on the square, and all of the markers will be on display in the History Museum. The original markers were funded with the support of local donors and designed by the Wilson's Creek NB Foundation. They were installed by the City of Springfield and dedicated on May 19, 2001.

The 1863 Battle of Springfield took place in what is now downtown Springfield. One hundred fifty years ago, Federal troops and Missouri Militia led by Brig. General Egbert Brown successfully defended the city and the Union supply depot located here against an attack by Confederate cavalry under the command of Brig. Gen. John S. Marmaduke. The battle lasted from dawn to dusk, ending when the last Confederate assault was repelled and Marmaduke's forces withdrew to the Phelps Farm (present day Phelps Grove Park). Of the 4,000 Federal and Confederate troops present, more than 400 were killed or wounded.

Established in 1950, the Wilson's Creek National Battlefield Foundation is one of the oldest private sector support groups associated with the National Park Service. It is a non-profit corporation with IRS 501(c) (3) status.

Since the Foundation's initial purchase of 37 acres on Bloody Hill, site of the heaviest fighting in the battle, the Foundation has worked to preserve and protect the park. The goal of the Foundation is to enhance awareness and appreciation of this national treasure—a haven for historians and those who enjoy the outdoors.


